- 3) Students are welcomed to practice in our studios. Please contact Harmony Music Company staff for more information.
- 4) Unless otherwise notified, all scheduled lessons will be held as usual on all school holidays.
- 5) <u>Typhoon, and Rainstorm Signals</u>: When Typhoon No. 8 or Higher Signal and/or Black Rainstorm Signal is cancelled before 3PM: students can call 23812025 after 2 hours since cancellation for information; When Typhoon No. 8 or Higher Signal and/or Black Rainstorm Signal is cancelled after 3PM: All scheduled classes will be suspended; When Typhoon No. 8 or Higher Signal and/or Black Rainstorm Signal is cancelled within 2 hours of you scheduled class time, your class will also be suspended.
- 6) Students are responsible for any damage they do to classroom property, including but not limited to musical instruments, whiteboards, benches, chairs, carpet and audio equipment.
- 7) Smoking, eating, drinking, photography, and recording are prohibited in the classrooms.
- 8) Harmony Music Company is not liable for any students' or visitors' loss or stolen property.
- 9) Students are not allowed to transfer from one class to another without the approval and confirmation of the administration office.
- 10) Payments made by cheque should be crossed and made payable to "Harmony Music Company" with student name and code.
- 11) For individual or Group lessons: Unless otherwise notified, tuition fees must be paid for the whole session (4 lessons for each session) before the start of lessons. Tuition fees for the next session must be paid in advance on the forth lesson of the previous session.
